### Your concerns regarding fast-tracked advancement of Bill PL 539/2024

Dear Capt. Barrionuevo,

the Austrian Cockpit Association wants to show you our support regarding the problems you are facing at SNA at the moment.

Good working conditions are not only a matter of labor law, but are also crucial to ensuring flight safety. The Bill PL 539/2024 imposes a major threat if it comes into force. You will have to compete with foreign crews who will most probably work under worse conditions and this will put pressure on you and your contracts.

And it is clearly not just external competition that jeopardizes safety, but also the lack of progress on fatigue management and other important and long-awaited improvements in your collective bargaining agreement.

Liberalization always has an impact on working conditions. But we as pilots must send a clear message: **Well-trained, sufficiently rested, and healthy crews are essential for flight safety!**

We hope, the establishment of a constructive dialogue between the airline, the government and pilot representatives will be successful soon.


